# **Cookie Statement**

STP Tax's website uses cookies. Cookies are small text files that are placed on your computer when you visit our website.

We use cookies to personalise content and advertisements, to provide social media features and to analyse our website traffic. In addition, we share information about your use of our websites with our advertising and analytics partners.


